## Testing Program

### **Opt-In Testing Program for Residential Services with Irrigation Systems**

Moore County Public Works is excited to offer a new service to residential customers who have irrigation BFPs. It is the goal that this new service will streamline the testing process for you. Participation in this program is optional. If you prefer to directly retain your own testing contractor, you may do so as long as you remain compliant with the testing requirements. Under the new program, the annual backflow test associated with your lawn irrigation system will be performed by an approved tester of Moore County Public Works. Testing will typically begin in mid-April and continue through the end of October. The program includes the testing of your assembly. While this program is being offered at no charge, any fees associated with non-compliance will be billed on the account holder's utility bill.

**\*\*Please note, the County is not responsible for backflow preventers that freeze and are not winterized properly.\*\***

### **Testing of Backflow Preventers**

The Moore County Cross Connection Control Ordinance requires testing of backflow preventers (BFPs) to ensure they are in good working order to protect the quality of water for you and the rest of the water users. The only method to determine satisfactory operation of backflow prevention assemblies is to have them tested by a certified tester with approved test equipment and the results submitted to the County.

### **What to Expect**

The testing process requires a 15-minute interruption of water service, and less than one gallon of water is used to perform the test. You will be notified if your backflow preventer did not pass the test.

### **How to Check Your Testing Status**

All backflow tests will be tracked by Moore County. The utility account holder will receive the test results.

### **If You Elect to Not Opt-In**

Moore County requires annual testing of backflow prevention assemblies. If you wish to not Opt-In to the program, the Public Works Department vendor will establish the annual testing schedule and mail notifications to homeowners approximately 60 days prior to their due date. Account holders who fail to have their backflow prevention assemblies tested and submitted by the deadline are subject to penalty for violating the County Ordinance.
