INSTRUCTIONS

1. **Occupancy Tax.** Six percent (6%) of gross receipts derived from the rental of any room, lodging, or similar accommodation furnished by a hotel, motel, inn, tourist camp, bed and breakfast, or similar place that is subject to sale tax imposed by the State of North Carolina under G.S. 105-164.4(a)(3) and 153A-155. This tax is in addition to any state or local sales tax.
2. **Exceptions.** This tax does not apply to accommodations furnished by non-profit, charitable, educational, or religious organizations when furnished in furtherance of their nonprofit purpose.
3. **Collection of Tax.** Every operator of a business subject to the tax levied under this section shall, on and after the effective date of the levy of the tax, collect the tax. This tax shall be collected as part of the charge for furnishing a taxable accommodation. The Tax shall be stated and charged separately from the sales records, and shall be paid by the purchaser to the operator of the business as a trustee for and on account of the Moore County. The tax shall be added to the sale price and shall be passed on to the purchaser instead of being borne by the operator of the business.
4. **Payment of Tax and Tax Report Forms.** The taxes due and payable to Moore County in monthly installments on or before the 20th day of the month following the month in which the tax accrues. Every person, firm, corporation, or association liable for the tax shall, on or before the 20th day of each month, prepare and render a return on the front of this form. The business should make copies of this form as needed.
5. **Failure to File.** A 5% penalty will be assessed if a return is not filed by the due date.
6. **Failure to Pay.** A 10% penalty, not less than \$5.00 will be assessed if the tax is not paid by the due date.
7. **Failure to File and Pay.** Will result in imposition of BOTH penalties in #5 & #6.
8. **Additional Penalty.** An additional 5% penalty, not to exceed 25%, shall be assessed in each additional month a return is not filed.
9. **Failure to pay which is determined to be willful or fraudulent could result in increased penalties and potential punishment as a Class 1 misdemeanor as outlined in G.S. 105-236.**
