**B-2**

A district to provide for the development of commercial and service centers that serve community, countywide, or regional commercial needs, are accessible by residents from surrounding neighborhoods, and are configured to minimize conflicts with surrounding residential areas.

## SETBACKS AND DIMENSIONAL REQUIREMENTS

### Lot Dimensions

Minimum Lot Size	10,000 square feet
Minimum Lot Width	75 feet
Minimum Lot Frontage	100 feet
Maximum Building Height	40 feet

### Principal Structure Setbacks

Front Setback	50 feet
Side Setback	None
Side Setback (Corner)	25 feet

### Rear Setback
