1. **Question:** Could clarify the exact scope of what this bid entails. Does this pertain to water/sewer pump & motor repairs (waste pumps, well pumps, booster pumps) or does this pertain to water/sewer line repairs, since the bid form mentions asphalt repairs?
Answer: The bid form has been updated (attached). This project is for water/sewer pump & motor repairs. Please use the corrected Revised Bid Form provided with this addenda for your response.
2. **Question:** The informal bid request sealed bids are due by 4:00pm on Friday October 10, 2025, but it mentions on page 6 of the document, sealed bids are due by 4:00pm on Thursday October 2, 2025. Please verify which day bids are due
Answer: Sealed Bids are now due by **4:00 pm Tuesday, October 14, 2025.**
3. **Question:** Can get the electrical scope? Are there drawings I can look at?
Answer: Please refer to the bid document scope of work for the electrical scope? Moore County Public Works operates 6 water distribution booster stations, 17 water supply wells (with 3 more soon to be added), and more than 40 sanitary sewer lift stations. Construction and as-built drawings, however, are not available for these as part of this bid announcement.

No further questions will be accepted. Sealed bids are due by 4:00:00 PM EST Tuesday, October 14, 2025 to Terra Vuncannon at **1 Courthouse Square, Carthage, NC 28327**. For your convenience, a Bid Drop-Off Box is located in the lobby at 1 Courthouse Square (Historic Courthouse). Opening will not be public.
