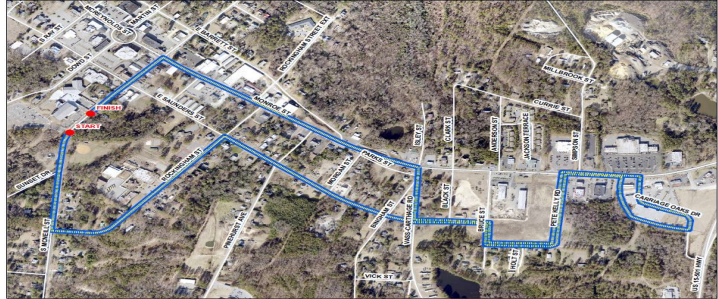

**EVENT LOCATION: 302 S. McNeill St, Carthage, NC.** From 8 am – 11 am, informational stations will be available for your enjoyment. Included are booths from the Sheriff's Office/Animal Services, Parks & Recreation, Health Department, a fire truck, and an EMS ambulance.
