3.	An animals' behavior may change after it leaves the Shelter and acclimates itself to a different environment.	
4.	The animal may be a greater than normal FLIGHT RISK until it acclimates to a new home.	
5.	I have been advised whether or not the animal has displayed aggression towards other dogs or cats.	
6.	I have been advised whether or not the animal has known medical conditions that will require treatment by a veterinarian such as heartworms, allergies, or other known conditions.	
7.	If the animal is a cat and has been declawed, the cat will need to be kept EXCLUSIVELY indoors.	
8.	State and County law requires that ALL animals four (4) months or older must be vaccinated against rabies and must have tags displayed on the collar.
