1. Question: Can a survey/locate be provided?
Answer: Please see attached drawings with locator information.
2. Question: Is the LF for South Street 1950-60 or 2730?
Answer: The bid form is correct. We added the 2" water main along Scott Avenue and Front Street increasing to 2730 LF.
3. Question: Will contractor need to bore or trench at the block walls on South Street?
Answer: Contractor may bore or trench.
4. Question: How will contractor need to test on Trade Street?
Answer: Contractor will be responsible to install the proper equipment to blow off water main.
5. Question: Will contractor be required/allowed to work nights and weekend/
Answer: The contractor is allowed to work nights and weekends if coordinated with Moore County. No work that requires inspection can be done unless it is left open for inspection.
