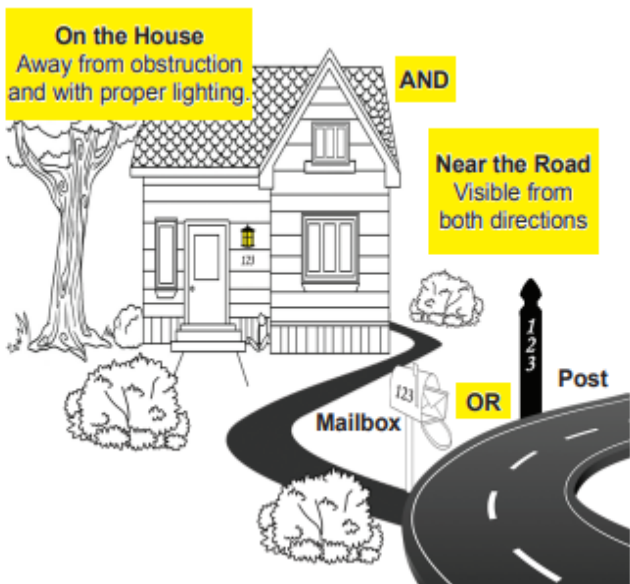

Identification for Utility Companies. New services or respond to repair for water, sewer, phone, power, TV, or internet.

Section IV. Addressing.**

F. Display of Road Address Numbers. Once assigned, road address numbers must be clearly displayed so the location can be easily identified from the road.

1. Residential properties guidelines are located 2018 North Carolina Residential Code, Section R319, Site Address, R319.1 Address numbers.
2. Commercial properties guidelines are located 2018 North Carolina Fire Code, Section 505, Premises Identification, 505.1 Address identification.

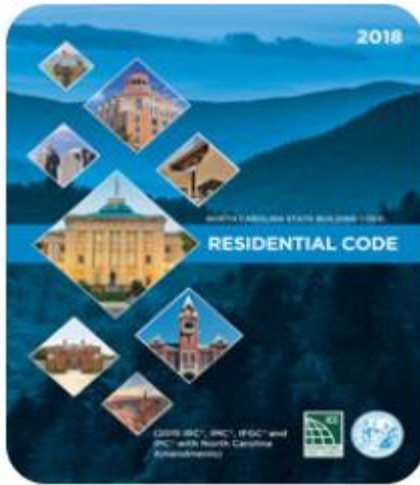

The correct style of numbering can be found at your local hardware store and may be available at your local fire department.



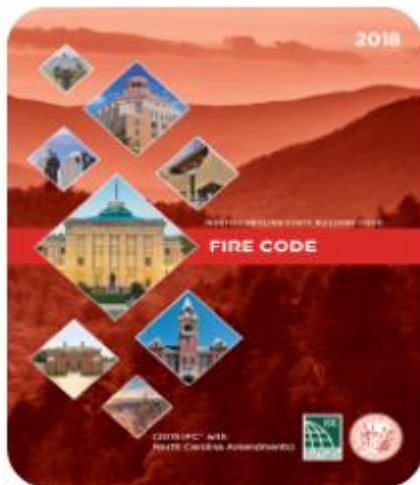

2018 North Carolina State Building Code: Residential Code

SECTION R319 SITE ADDRESS

R319.1 Address identification. Buildings shall be provided with *approved* address identification. The address identification shall be legible and placed in a position that is visible from the street or road fronting the property. Address identification characters shall contrast with their background. Address numbers shall be Arabic numbers or alphabetical letters. Numbers shall not be spelled out. Each character shall be not less than 4 inches (102 mm) in height with a stroke width of not less than 0.5 inch (12.7 mm). Where required by the fire code official, address identification shall be provided in additional *approved* locations to facilitate emergency response. Where access is by means of a private road and the building address cannot be viewed from the public way, a monument, pole or other sign or means shall be used to identify the structure.



2018 North Carolina State Building Code: Fire Prevention Code

SECTION 505 PREMISES IDENTIFICATION

505.1 Address identification. New and existing buildings shall be provided with *approved* address identification. The address identification shall be legible and placed in a position that is visible from the street or road fronting the property. Address identification characters shall contrast with their background. Address numbers shall be Arabic numbers or alphabetical letters. Numbers shall not be spelled out. Each character shall be not less than 6 inches (153 mm) high with a minimum stroke width of $\frac{3}{4}$ inch (20 mm). Where required by the *fire code official*, address identification shall be provided in additional *approved* locations to facilitate emergency response. Where access is by means of a private road and the building cannot be viewed from the *public way*, a monument, pole or other sign or means shall be used to identify the structure. Address identification shall be maintained.

505.2 Street or road signs. Streets and roads shall be identified with *approved* signs. Temporary signs shall be installed at each street intersection when construction of new roadways allows passage by vehicles. Signs shall be of an *approved* size, weather resistant and be maintained until replaced by permanent signs.
