Amateur Athletic Waiver and Release of Liability

In consideration of being allowed to participate in any way in Moore County Parks & Recreation athletics/fitness/sports program, and related events and activities, including practices, games and travel, the undersigned:

1. Agrees that prior to participating, he/she will inspect the facilities and equipment to be used, and if he/she believes anything is unsafe, he/she will advise the coach, volunteer, or supervisor of such condition(s) and refuse to participate.
2. Acknowledges and fully understands that each participant will be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from his/her own actions, inactions, or negligence, but the actions, inactions, or negligence of others, the rules of play, or the condition of the premises or of any equipment used. Further, that there may be other risks not known to us or not reasonably foreseeable at this time.
3. Assumes all the foregoing risks and accepts personal responsibility for the damages following such injury, permanent disability, or death. Understands that to promote total health and physical fitness Moore County Parks and Recreation strongly recommends events of longer duration and lower intensity and that higher-intensity types of activities are offered primarily for the conditioned, trained athlete.
4. Releases, waives, discharges, and covenants not to sue the County of Moore, its affiliated clubs, their respective administrators, directors, agents, coaches, and other employees of the organization, other participants, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event, from any and all liability to each of the undersigned, his or her heirs and next of kin for any and all claims, demands, losses, or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the above named associates.
5. Is aware that no insurance coverage or insurance policy is provided to cover participants.
6. Admits they are in good enough physical condition to safely participate and acknowledges they are strongly encouraged to consult their physician before participating. Also, grants permission for emergency transportation to a medical facility and for medical treatment if necessary.
7. Grants permission for pictures that may be secured of participants engaged in activities in which they may be included, may be used at the discretion of the Recreation Department.

The undersigned has read the above waiver, understands its content, assumes all risk and signs it voluntarily.

NOTICE AS TO RISK RELATED TO COVID-19 AND ASSUMPTION OF RISK BY ADULT PARTICIPANT:

By registering for participation in a Moore County Parks and Recreation Activities' program, or Renting or Using the Moore County Parks and Recreation Picnic Shelter facilities or engaging in water activities at the Moore County Splash Pad, I am acknowledging that an inherent risk of exposure to COVID-19 exists in any public place where people are present. With my initials below, I acknowledge that COVID-19, the illness caused by the "novel coronavirus", is an extremely contagious virus that spreads easily through the air by coughing or sneezing, person-to-person contact including touching and shaking hands or through touching your nose, mouth or eyes before washing hands. The World Health Organization (WHO), The Center for Disease Control (CDC), and additional Federal, State, and local health agencies recommend social distancing as one of the means to limit or slow the spread of the virus. Complications of COVID-19 may include severe illness, long term, or permanent disabilities, worsening of existing chronic medical conditions or death. I understand that participating in a Moore County Parks and Recreation Activities' program or accessing Moore County Parks and Recreation Facilities; including but not limited to Picnic Shelter areas, County Parks facilities and equipment and Splash Pad water activities could increase the risk of exposure to and contracting COVID-19. I understand and agree that the County of Moore and the Moore County Parks and Recreation Department make no representations whatsoever that COVID-19 exposure or infection will not occur through participation a Moore County Parks and Recreation program or accessing Parks and Recreation's facilities.

As a participant in a Moore County Parks and Recreation program, or user of the County facilities and equipment, I fully and unconditionally release and forever discharge and covenant to hold harmless the County of Moore and the Moore County Parks and Recreation Department, and all of its past, present, and future officers, directors, shareholders, employees, agents, representatives, insures, predecessors, and successors from and all claims, actions, causes of action, suits at law or in equity, demands, judgments, damages, and controversies that I now have or ever had or ever will have, whether known or unknown, whether now accrued or hereafter maturing or accruing, whether for personal injury, property damage, or other economic loss, emotional distress, punitive damages, or otherwise on account of, connected with, or growing out of my contracting COVID-19, or being exposed to COVID-19 as a result of participation in a Moore County Parks and Recreation's program or utilizing and accessing the Parks and Recreation's facilities.
