### MOORE COUNTY TAX LISTING SCHEDULE

2017

IN ACCORDANCE WITH N.C. GENERAL STATUTE 105-308 ALL PERSONS WHO OWN PERSONAL PROPERTY ARE REQUIRED TO LIST ANNUALLY WITH THE COUNTY ASSESSOR; ALL NON-REGISTERED VEHICLES, MULTI-YEAR TAG VEHICLES, MOBILE HOMES, WATERCRAFT, MOTORS, AIRCRAFT, INCOME PRODUCING FARM EQUIPMENT, BUSINESS FIXED ASSETS AND SUPPLIES, AND ALL OTHER PERSONAL PROPERTY. **TAXPAYERS ARE NOT REQUIRED TO LIST REGISTERED (LICENSED) VEHICLES.** THE TAX BILLING PROCESS ON REGISTERED VEHICLES WILL BE TIED TO THE ANNUAL REGISTRATION (LICENSE PLATE RENEWAL). TAXPAYERS WHO OWN A NON-REGISTERED / NON-LICENSED VEHICLE, MULTI-YEAR TAG VEHICLE, MOBILE HOME, WATERCRAFT, MOTORS, AIRCRAFT, INCOME PRODUCING FARM EQUIPMENT, BUSINESS FIXED ASSETS AND SUPPLIES, OR ANY OTHER PERSONAL PROPERTY, ARE REQUIRED TO LIST SUCH PROPERTY ANNUALLY. TAXPAYERS WHO OWNED AND LISTED PERSONAL PROPERTY IN 2016 SHOULD RECEIVE A LISTING FORM IN THE MAIL DURING THE MONTH OF JANUARY. TAXPAYERS WHO OWN REAL ESTATE ONLY WILL NOT RECEIVE A LISTING FORM IN THE MAIL; HOWEVER, IF NEW CONSTRUCTION OR IMPROVEMENTS TO EXISTING STRUCTURES, DWELLINGS, ETC. WERE MADE DURING 2016, IT IS THE PROPERTY OWNER'S RESPONSIBILITY TO NOTIFY THE TAX DEPARTMENT OF SUCH CHANGES DURING THE MONTH OF JANUARY. ALL LISTING FORMS **MUST BE SIGNED BY THE PROPER INDIVIDUAL IN ORDER TO BE COMPLETE.** TAXPAYERS WHO ARE REQUIRED TO LIST, BUT DO NOT RECEIVE A FORM BY MAIL, SHOULD CONTACT THE TAX DEPARTMENT PRIOR TO **JANUARY 31<sup>st</sup>, 2017** AT 947-2255 IN ORDER TO LIST ALL PERSONAL PROPERTY AND/OR NEW CONSTRUCTION OR IMPROVEMENTS TO REAL PROPERTY.

**PERSONS WHO ARE REQUIRED TO LIST, MUST DO SO BETWEEN JANUARY 3<sup>rd</sup> AND FEBRUARY 1<sup>st</sup>, 2017.** ANY LISTING SUBMITTED BY MAIL SHALL BE DEEMED TO BE FILED AS OF THE DATE SHOWN ON THE POSTMARK AFFIXED BY THE UNITED STATES POSTAL SERVICE. IF NO DATE IS SHOWN OR IF THE POSTMARK IS NOT AFFIXED BY THE UNITED STATES POSTAL SERVICE, IT SHALL BE DEEMED TO BE FILED WHEN RECEIVED. FAILURE TO LIST WILL RESULT IN PENALTIES.
